4. **1st Reading Of Ordinance Number 2021-01** - An Ordinance To Repeal Ordinance 2012-012 And Authorize With A Replacement Ordinance The Williamsburg Aeronautics Commission: Setting Forth The Duties, Responsibilities, Function Of The Commission; To Provide For The Appointment Of Its Members And Election Of Its Officers And Membership (Title Only).
5. **1st Reading Of Ordinance Number 2021-02** - An Ordinance Amending Ordinance No. 2015-007 To Further Define A "Connected Customer" In Section 2 (B) And (C) Thereof.
6. **1st Reading Of Ordinance Number 2021-03** - Authorizing The Development Of A Jointly Owned And Operated Industrial/Business Park Between Georgetown County And Williamsburg County, Such Industrial/Business Park To Be Geographically Located In Each County And Established Pursuant To South Carolina Code Annotated Section 4-1-170; To Provide For A Written Agreement Between Georgetown County And Williamsburg County To Provide For The Expenses Of The Park, The Percentage Of Revenue Application, And The Distribution Of Fees In Lieu Of Ad Valorem Taxation; And Other Related Matters.
